### INVESTMENT OBJECTIVE AND POLICY

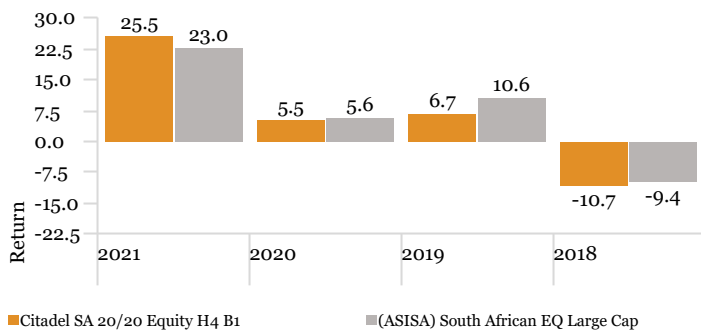
The Citadel SA 20/20 Equity H4 Fund will hold a concentrated portfolio of 20 equity shares which will be chosen in various stages of value, growth and momentum, with roughly a third of the portfolio being in each of these phases at any given point in time thereby providing diversified returns. The investment manager will also use a number of different valuation models to assist with the selection process. These models blend into a process that is a style-neutral, buy and hold approach with a low turnover of investments selected for long-term holding over a 20 year period. This differs markedly from the universe of equity funds in South Africa given long holding periods and a concentrated portfolio of just 20 stocks. The fund's investment universe will consist predominantly of equity securities, but may also include fixed interest and property securities and assets in a liquid form. The fund may also include participatory interests in portfolios of collective investment schemes, as permitted by legislation. Listed and unlisted financial instruments may be used for efficient portfolio management only.

### RISK REWARD PROFILE



This portfolio invests predominantly in South African listed equity securities, including listed property shares. In terms of the above risk reward profile, the portfolio has the highest risk rating due to the nature of its investments, which may be subject to risks which include, but are not limited to, adverse local and foreign stock market conditions, political and macroeconomic events, company earnings and significant corporate events, as well as currency fluctuations. 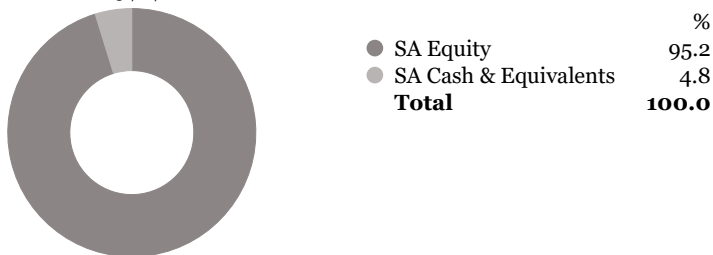

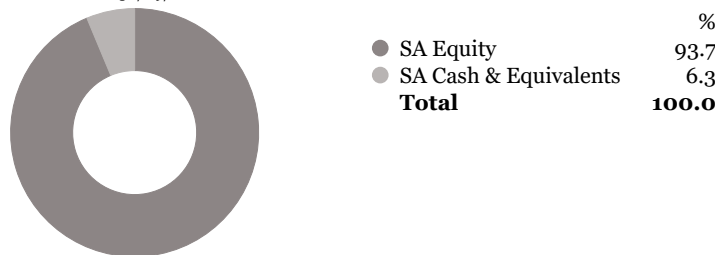


### ASSET ALLOCATION (MORNINGSTAR, LOOK THROUGH) - MARKET VALUE

### FUND COMMENTARY

The Citadel SA 20/20 Equity H4 Fund (‘the fund’) delivered 14.6% in Q4-2021 as the FTSE/JSE Capped Top 40 Index rose 14.2%. At sector level, the fund benefitted from overweight allocations to health care, financials, industrials along with an overweight allocation to materials. Detractors included overweight allocations to energy and consumer staples. At stock level, the fund benefitted from overweight positions in Naspers, Aspen, Absa and Old Mutual along with an overweight position in AngloGold. Detractors included overweight positions in Standard Bank, Spar, Remgro and FirstRand along with overweight exposures to Richemont and Anglo American Platinum. Trading activity included exiting the positions in Sanlam and Spar, using the proceeds to initiate a position in Absa, while adding to existing positions in Mondi and Bidcorp. The exposure to Richemont and Shoprite, both of which performed well, was reduced in favour of increased exposure to Exxaro and British American Tobacco. The fund continues to adhere to its policy.

### About the manager, trustee and scheme

This portfolio was established by H4 Collective Investments (RF) (Pty) Ltd, registration number 2002/009140/07 (“the manager”) of The Citadel, 15 Cavendish Street, Claremont, 7708 (telephone +27 21 670 9100) as part of the H4 Collective Investments Scheme (“the scheme”). The trustee of the scheme is the Standard Bank of South Africa Limited of 9th Floor, Standard Bank Centre, 5 Simmonds Street, Johannesburg, 2001 (telephone +27 11 636 9111/2).

### About the investment manager

The manager has appointed Citadel Investment Services Proprietary Limited, registration number 1996/006847/07 (“Citadel”), as the investment manager of the portfolio. Citadel is licensed as a financial services provider in terms of the Financial Advisory and Intermediary Services Act, 2002. Citadel Asset Management is the asset management division of Citadel.

### Risk warning

### Disclosures in respect of the Citadel SA Money Market H4 Fund only

A money market portfolio is not a bank deposit account. The price of participatory interests is targeted at a constant value. The total return to the investor is made up of interest received and any gain or loss made on any particular investment, and in most cases the return will merely have the effect of increasing or decreasing the daily yield, but in the case of abnormal losses it can have the effect of reducing the capital value of the portfolio. Excessive withdrawals from the portfolio may place the portfolio under liquidity pressures – in such circumstances a process of ring-fencing of withdrawal instructions and managed pay-outs over time may be followed. The yield is calculated monthly using historical figures and is annualised.

These funds were originally established under the Sanlam Collective Investments Scheme (SCI) under the names CAM Fortis Institutional Fund, CAM Universum Institutional Fund, CAM Optima Fund, CAM Ascendo Fund of Funds and CAM Balanced Fund, respectively. These funds were all established under the H4 Collective Investments Scheme on 29 April 2013 and amalgamated with their respective SCI counterparts on 28 August 2013. The amalgamated portfolios continued under their current names under the H4 Collective Investments Scheme, save for the Citadel Worldwide Equity H4 Fund which continued under the name Citadel SA Equity H4 Fund; and was thereafter renamed the Citadel Worldwide Equity H4 Fund. On amalgamation, the Citadel SA Money Market H4 Fund did not retain the performance history of the CAM Fortis Institutional Fund.

### **Disclosure in respect of the H4 Focused Wealth Fund**

This fund was originally established under the IP Collective Investment Scheme under the name IP Focused Wealth Fund. The H4 Focused Wealth Fund was established under the H4 Collective Investments Scheme on 3 February 2017 and amalgamated with the IP Focused Wealth Fund on 30 May 2017. The amalgamated portfolio continued under the name H4 Focused Wealth Fund.

### **Disclosures in respect of third-party-named portfolios**

The value of participatory interests is calculated on a NAV basis. The price of participatory interests is calculated by dividing the NAV by the number of participatory interests in issue. Prices are published daily in local newspapers.
